Conclusion on the assessment of the corporate governance system of Private joint stock bank «Trustbank» has been prepared by the «PREMIUM FINANCE» LLC.

An independent assessment of the corporate governance system of PJSB «Trustbank» was conducted according to the agreement № 5/K24 of February 29, 2024. The independent evaluation was carried out in accordance with the legislation of the Republic of Uzbekistan, including the Corporate Governance Code approved by the Commission on increasing the efficiency of joint stock companies and improving the corporate governance system (Minutes No.9 of December 31, 2015).

The purpose of assessment is formation of independent objective opinion on the status of corporate governance system in PJSB «Trustbank».

Assessment of corporate governance system in PJSB «Trustbank» was conducted on the basis of Questionnaire approved by the State Competition Committee of the Republic of Uzbekistan and Scientific and educational center for corporate governance dated July 25, 2016.

«PREMIUM FINANCE» LLC is responsible only for expressing its opinion on the status of corporate governance in PJSB «Trustbank», based on the documents, reports, information and other materials provided by the Bank.

Responsibility for the completeness, content and reliability of the submitted documents, reports, information and other materials is borne by PJSB «Trustbank». The authenticity and reliability of the received documents, reports, information and other materials was not checked and not contested.

«PREMIUM FINANCE» LLC confirms that the documents, reports, information and other materials provided by the Bank provide are sufficient for expressing an independent opinion on the state of corporate governance in PJSB «Trustbank».

Based on the results of the assessment of the corporate governance system, the actual valuation of PJSB «Trustbank» is **1 038 points** or **86,50%** according to the percentage scale and, according to «PREMIUM FINANCE» LLC, the level of the corporate governance system in the Bank is recognized as «**high**».
